**ADMISSION TO ACADEMIC COURSES OF LEVEL I AND II (Bachelor's and Master's)
AND PROPAEDEUTIC COURSES A.Y. 2024/2025**

Non-EU students requiring visas

Applicants from outside the European Union requiring visas must compulsorily register in advance through the University portal from the page <https://www.universitaly.it/>. When the Secretariat gives them the OK via email, they can proceed to registration on the Isidata portal

For such candidates, the admission tests will be held during the following periods:

A. July 08th to July 15th 2024 for non-EU candidates who:

- as of June 15 2024, are already registered on Universitaly
- are in possession of a regular entry visa
- and who will fulfill the registration on the Isidata portal, following the directions provided by the Secretariat by June 21, 2024.

For these candidates, it is mandatory to pass in advance the test of Italian language proficiency which will take place on 17th June starting from 5 p.m.

B. September 23rd to 25th 2024 for non-EU candidates who:

- are registered on Universitaly
- who are in possession of regular entry visas and
- who will fulfill the registration on the Isidata portal, following the directions provided by the Secretariat, by September 16th

For these candidates, it is mandatory to pass in advance the test of the language proficiency for access to the courses, which will be held on September 18 from 5 p.m.

Applications for admission and documentation

All applicants must complete the admission applications exclusively electronically by accessing the following link (Isidata Services):

Two types of payment must be made to take the entrance examination as follows

1) Ministerial admission fee of €6.04 to be made by bank transfer to the IBAN account: IT45 R 0760103200 000000001016 payable to **Agenzia delle Entrate - Centro Operational Center of Pescara** with the reason for payment: **“Admission Fee”**.

The relevant **receipt of payment (so-called “accounting”)** issued by the bank must obligatorily be attached in the Fees section.

2) Admission fee to be generated from the Fees section (amounts are below) of the Isidata portal and to be paid using the **PagoPa system**:

- for admissions to propaedeutic courses only, an amount as admission fee equal to a € 40,00;
- only for admissions to the three-year or single courses planned within the three-year Level I course, an amount as an admission fee of € 60.00;
- only for admissions to the two-year or single courses provided within the two-year Level II course, an amount as an admission fee of € 80.00;

The following docs must also be uploaded to Isidata, in the “ATTACH DOCUMENTATION” section:

- (a) photocopy of a valid identity document of the candidate;
- (b) photocopy of a valid identity document of the candidate's parent if a minor ;
- (c) only in cases of admission to the Master degree (two year program), subject to obtaining the Bachelor's degree, the form called “Admission to the two-year degree subject to obtaining the degree,” which can be downloaded from the link <https://www.consba.it/getFile.php?id=3660>

d) for all applicants of non-Italian citizenship: copy of the required documentation required by the Secretariat (appropriate entry visa and/or residence permit, translated degree with declaration of value on site, possible certification of language skills Italian);

e) only in cases of non-EU candidates already resident in Italy with a valid residence permit valid: self-certification downloadable from the link <https://www.consba.it/getFile.php?id=3661>

Students applying for admission **to three-year (Bachelor's) academic programs** must compulsorily specify in the appropriate “Other Examinations Achieved” field of the “Other Qualifications” section whether they hold a musical baccalaureate diploma or licenses from the previous system or certifications of pre-academic or propaedeutic courses (indicating place and year of attainment) as indicated in the tutorial.

For candidates of all courses except those participating for the disciplines of the area of Composition and Conducting, it is mandatory to participate in the second round

of the Theory, Rhythmic and Musical Perception entrance examination.

Candidates with:

- High School Musical Baccalaureate Diploma;
- previous license in Theory, Solfeggio and Musical Dictation;
- final certification in Theory, Rhythmic and Musical Perception obtained at the Conservatorio "N. Piccinni."

This test will be held on July 19th from 09:30 a.m. according to a time schedule which will be subsequently available from the institution's website.

For **non-EU applicants requiring visas** who will take the entrance exam in September, a different date will be communicated later.

For candidates participating for the disciplines of Composition and Conducting, Theory, Rhythmic and Musical Perception will be scheduled as an optional entrance test as an additional area of assessment.

For candidates in Composition, Conducting, Choral Conducting and Composition only choral or Instrumentation for wind orchestra, participation in the second test of the entrance examination of:

Score Reading on July 22, 2024 from 8:30 am.

For non-EU candidates requiring visas who will take the entrance exam in September, a different date will be announced later.

Details of the compulsory second and additional entrance tests (which will be held by 31/10/2024 or otherwise after registration) will be published in a separate notice available from the link <https://www.consba.it/getFile.php?id=3662>

Candidates who are **successful in the entrance examinations** are included in a **ranking** ordered by score in hundredths and subordinately, in the event of a tie, by lower age age.

Enrollments will be arranged on the basis of the Institute's planning by the competent educational facilities. **Inclusion in the list of eligible students, therefore, does not alone constitute a right to enrollment.**

The start of matriculation procedures will be notified to admitted Candidates by means of publication in the News section of the website <https://www.consba.it>

Possible enrollment for candidates for admission to Level I (three-year) academic courses who have obtained a grade between 50 and 59 hundredths is subject to the fulfillment of the additional educational obligations noted by the Examination Committee in the course of conducting of the I test pertaining to the discipline characterizing the course.

The findings related to the additional educational obligations attributed by the Examination Committee in the context of the conduct of the Second Test afferent to the skills of Theory, Rhythmic and Musical Perception and Score Reading. Enrollment in single courses goes in the queue for courses that provide for the award of the

Academic Diploma.

All candidates are included in the rankings subject to verification that they meet the requirements of admission.
